On the nine rolls of this microfilm publication are reproduced the records from the decimal file of the Department of State, 1910-29, that relate to political relations between Yugoslavia and certain other states during the period 1919-29. The records, consisting of bound volumes and unbound documents, are mostly instructions to and despatches from diplomatic and consular officials; the despatches are often accompanied by enclosures. Also included in these records are notes between the Department of State and foreign diplomatic representatives in the United States, memorandums prepared by officials of the Department, and correspondence with officials of other Government departments and with private firms and persons. The Lists of Documents or "purport sheets" reproduced on roll 1 give brief abstracts of the documents reproduced in this microfilm publication and serve as a finding aid to the documents themselves. The arrangement of the entries on these lists generally corresponds to the arrangement of the documents in the file.

From 1910 to 1963 the Department of State used a decimal system for its central files, assembling and arranging individual documents according to subject and assigning decimal file numbers. The decimal file consists of nine primary classes numbered 0 through 8, each covering a broad subject area. The records reproduced in this microfilm publication are in Class 7, Political Relations of States. Each country has been assigned a two-digit number. The country numbers assigned to Yugoslavia and to Bulgaria, for example, are 60h and 74, respectively. Thus the documents bearing the file number 760h.74 concern political relations between Yugoslavia and Bulgaria.

When two country numbers are used in a single file number, the lower number is the controlling one and precedes the decimal point; the number after the decimal point must be higher. Most of the documents reproduced in this microfilm publication concern relations between Yugoslavia and those countries assigned a number higher than 60h. Documents on relations between Yugoslavia and countries having a number lower than 60h would be among records for the other country; for example, those on relations between Yugoslavia (60h) and France (51) would be filed under 751.60h. Documents relating to Yugoslav relations with other countries in general, however, are filed under 760h.00 and are included in this microfilm publication.

When one or more digits follow the second country number, they represent a specific subject. This number, in turn, may be followed by a slant mark (/). In such cases the numbers after

the slant mark were assigned to individual documents as they were accumulated on a specific subject. For example, a decimal file number taken from a document reproduced in this microfilm publication is 760h.7415/88. The number 15 following the country number for Bulgaria (74) signifies that the subject is boundary questions and the number after the slant mark indicates the number of documents on this subject.

The documents under one subject classification are generally in chronological order, coinciding with the document number assigned (which follows the slant mark). There are instances, however, when a document file number was not assigned until a date considerably later than the one on which the document was received.

Cross-reference sheets referring to related records under other subject classifications in the decimal file have been reproduced as they occur, and appropriate cross-reference notations appear in the Lists of Documents. Other cross-reference notations are to documents in the "numerical file," a system used for the central files of the Department of State for the period 1906-10. The checkmarks that appear by most entries in the left column of the Lists of Documents indicate that the papers are in the file; entries without marks, it is believed, refer to documents that were not among the records when they were received from the Department of State.

Some of the documents that have been checked in the Lists of Documents do not appear in this microfilm publication. The file contains security-classified documents and communications received from and classified by foreign governments and Federal agencies, in addition to those classified by the Department of State. Documents that have not been declassified are not available as part of this microfilm publication. The National Archives and Records Service does not have authority to make reproductions of such documents available to searchers.

The records reproduced in this microfilm publication are part of the records in the National Archives designated as General Records of the Department of State, Record Group 59.

Records closely related geographically and historically with those reproduced in this microfilm publication are those of internal affairs of Montenegro and political relations of Montenegro with the United States, 1910-29 (M349), and internal affairs of Serbia and political relations between Serbia and the United States, 1910-29 (M357). Both of these series were, for the most part, discontinued on August 9, 1919, when Serbia and Montenegro were incorporated into the Kingdom of the Serbs, Croats, and Slovenes, which later became known as Yugoslavia.

In the same record group also are despatches from U.S. Ministers to Serbia to the Department, 1900-1906 (T630); despatches from U.S. Ministers to Montenegro to the Department, 1905-6 (T525); notes from the Legation of Montenegro in the United States to the Department, 1896-1905 (T614); and despatches from U.S. consular officials at Belgrade, 1883-1906 (T513). Complementary to the despatches are instructions to consuls.

The arrangement of the diplomatic and consular series cited above was discontinued in 1906, when the Department of State adopted the practice of filing incoming and outgoing correspondence, memorandums, and other documents by subject in a single numerical series. Information on documents relating to Serbia and Montenegro for the 1906-10 period may be found through the use of card indexes and Lists of Documents in the National Archives.

Among the records in the same record group in the Department of State decimal file, 1910-29, are two other series regarding Yugoslav affairs that are closely related to the records reproduced in this microfilm publication. One is another series in Class 7, which concerns political relations between the United States and Yugoslavia (M362), and the other is a series in Class 8, which relates to the internal affairs of Yugoslavia (M358).

In Records of the Foreign Service Posts of the Department of State, Record Group 84, are records originally kept at U.S. diplomatic and consular posts. Among these are records of the U.S. Legation (later Embassy) in Yugoslavia (Serbia), 1882-1939, and of consular posts in that country.

Other records relating to Yugoslavia are among the Records of the American Commission To Negotiate Peace, Record Group 256. The general records of the Commission are available as Microfilm Publication M820.

On the single roll of this microfilm publication are reproduced the records from the decimal file of the Department of State, 1910-29, that relate to political relations between the United States and Yugoslavia during the period 1919-29. The records, consisting of bound volumes and unbound documents, are mostly instructions to and despatches from diplomatic and consular officials; the despatches are often accompanied by enclosures. Also included in these records are notes between the Department of State and foreign diplomatic representatives in the United States, memorandums prepared by officials of the Department, and correspondence with officials of other Government departments and with private firms and persons. The lists of Documents or "purport sheets" give brief abstracts of the documents reproduced on this microfilm publication and serve as a finding aid to the documents themselves. The arrangement of the entries on these lists generally corresponds to the arrangement of the documents in the file.

From 1910 to 1963 the Department of State used a decimal system for its central files, assembling and arranging individual documents according to subject and assigning decimal file numbers. The decimal file consists of nine primary classes numbered 0 through 8, each covering a broad subject area. Thus the documents bear the file number 711.60h and concern political relations between the United States and Yugoslavia.

When one or more digits follow the second country number, they represent a specific subject. This number, in turn, may be followed by a slant mark (/). In such cases the numbers after the slant mark were assigned to individual documents as they were accumulated on a specific subject. For example, a decimal file number taken from a document reproduced in this microfilm publication is 711.60h4/17. The number 4 following the country number for Yugoslavia (60h) signifies that the subject is naturalization and the number after the slant mark indicates the number of documents on this subject.

The documents under one subject classification are generally in chronological order, coinciding with the document number assigned (which follows the slant mark). There are instances, however, when a document file number was not assigned until a date considerably later than the one on which the document was received.

Cross-reference sheets referring to related records under

other subject classifications in the decimal file have been reproduced as they occur, and appropriate cross-reference notations appear in the Lists of Documents. Other cross-reference notations are to documents in the "numerical file," a system used for the central files of the Department of State for the period 1906-10.
