On the 5 rolls of this microfilm publication are reproduced the records from the decimal file of the Department of State, 1910-29, that concern political relations between the United States and France, St. Pierre and Miquelon, Martinique, Guadeloupe, French Indochina, the Society Islands, and Tunis. The records, consisting of bound volumes and unbound documents, are mostly instructions to and despatches from diplomatic and consular officials; the despatches are often accompanied by enclosures. Also included in these records are notes between the Department of State and foreign diplomatic representatives in the United States, memoranda prepared by officials of the Department, and correspondence with officials of other Government departments and with private firms and persons. The Lists of Documents or "purport sheets" filmed at the beginning of roll 1 give brief abstracts of the documents reproduced in this microfilm publication and serve as a finding aid to the documents themselves. The arrangement of the entries on these lists generally corresponds to the arrangement of the documents in the file.

From 1910 to 1963 the Department of State used a decimal system for its central files, assembling and arranging individual documents according to subject and assigning decimal file numbers. The decimal file consists of nine primary classes numbered 0 through 8, each covering a broad subject area. The records reproduced in this microfilm publication are in Class 7, Political Relations of States. The country numbers assigned to the United States and to France are 11 and 51, respectively. Thus the documents bear the file number 711.51 and concern political relations between the United States and France. The six areas for which records are also included in this series were each assigned a letter as follows: a (St. Pierre and Miquelon), b (Martinique), c (Guadeloupe), g (French Indochina), m (Society Islands), and s (Tunis), which is placed after the country number for France (51). Thus the documents bearing the file number 711.51a, for example, concern political relations between the United States and St. Pierre and Miquelon.

When one or more digits follow the second country number, they represent a specific subject. This number, in turn, may be followed by a slant mark (/). In such cases the numbers after the slant mark were assigned to individual documents as they were accumulated on a specific subject. For example, a decimal file number taken from a document reproduced in this publication is 711.5127/24. The number 27 following the country number for

France (51) signifies that the subject is an aerial navigation agreement, and the number after the slant mark indicates the number of documents on this subject.

The documents under one subject classification are generally in chronological order, coinciding with the document number assigned (which follows the slant mark). There are instances, however, when a document file number was not assigned until a date considerably later than the one on which the document was received.

Cross-reference sheets referring to related records under other subject classifications in the decimal file have been reproduced as they occur, and appropriate cross-reference notations appear in the Lists of Documents. Other cross-reference notations are to documents in the "numerical file," a system used for the central files of the Department of State for the period 1906-10. The checkmarks that appear by most entries in the left-hand column of the Lists of Documents indicate that the papers are in the file; entries without marks, it is believed, refer to documents that were not among the records when they were received from the Department of State.

Some of the documents that have been checked in the Lists of Documents do not appear in this microfilm publication. The file contains security-classified documents and communications received from and classified by foreign governments and Federal agencies, in addition to those classified by the Department of State. Documents that have not been declassified are not available as part of this publication. The National Archives and Records Service does not have authority to make reproductions of such documents available to searchers.

The largest group of records reproduced in this publication concern the Kellogg Anti-War Pact.

The records reproduced in this microfilm publication are part of the records in the National Archives designated as General Records of the Department of State, Record Group 59.

In the same record group are several diplomatic correspondence series containing additional documents on relations between France and the United States. There are copies of instructions from the Department of State to diplomatic and consular representatives of the United States, 1785-90 (M61, Foreign Letters of the Continental Congress and the Department of State), and 1791-1801 (M28); to U.S. Ministers to all countries, 1801-33 (rolls 1-8 of M77) and to U.S. Ministers to France, 1829-1906 (rolls 54-64 of M77); notes to foreign ministers and consuls in the United States from the Department, 1793-1834 (M38), and notes to the French Legation in the United States from the Department, 1834-1906 (rolls 21-26 of M99); despatches from U.S.

Ministers to France to the Department, 1789-1906 (M34); and notes from the French Legation in the United States to the Department, 1789-1906 (M53). Also related to matters concerning France are communications to special agents of the United States from the Department, 1823-86 (rolls 152 and 154 of M77), and some records among despatches from special agents of the United States to the Department, 1794-1906 (M37).

The method of arranging the diplomatic and consular series cited above was discontinued in 1906, when the Department of State adopted the practice of filing incoming and outgoing correspondence, memorandums, and other documents by subject in a single numerical series. Information on documents relating to France for the 1906-10 period may be found through the use of card indexes and Lists of Documents in the National Archives.

Among the records in the same record group in the Department of State decimal file, 1910-29, are two other series regarding French affairs that are closely related to the records

reproduced in this microfilm publication. One is another series in Class 7, which concerns political relations between France and Other States (M569), and the other is a series in Class 8, which relates to the internal affairs of France (M560). Also reproduced on microfilm are three related series concerning Morocco, 1910-29: internal affairs (M577), political relations with the United States (M578), and political relations with other states (M579).

Among Records of the Foreign Service Posts of the Department of State, Record Group 84, are records originally kept at U.S. diplomatic and consular posts. Among these are records of the U.S. Legation (later Embassy) in France, 1788-1935, and records of consular posts in that country. Available on microfilm is the correspondence of the U.S. Legation in France, 1835-42 (M14).

Other records relating to France are in Records of Boundary and Claims Commissions and Arbitration, Record Group 76. Among them are documents relating to the Claims Commissions of 1803, 1831, and 1880-93, in which France and the United States participated.

Records relating to France are also among Records of the American Commission To Negotiate Peace, Record Group 256.

The records, consisting of bound volumes and unbound documents, are mostly instructions to and despatches from diplomatic and consular officials; the despatches are often accompanied by enclosures. Also included in these records are notes between the Department of State and foreign diplomatic representatives in the United States, memoranda prepared by officials of the Department, and correspondence with officials of other Government departments and with private firms and persons. The Lists of Documents or "purport sheets" filmed at the beginning of roll 1 give brief abstracts of the documents reproduced in this microfilm publication and serve as a finding aid to the documents themselves. The arrangement of the entries on these lists generally corresponds to the arrangement of the documents in the file.

From 1910 to 1963 the Department of State used a decimal system for its central files, assembling and arranging individual documents according to subject and assigning decimal file numbers. The decimal file consists of nine primary classes numbered 0 through 8, each covering a broad subject area. The records reproduced in this microfilm publication are in Class 7, Political Relations of States. Each country has been assigned a two-digit number. The country numbers assigned to France and to Liberia, for example, are 51 and 82, respectively. Thus the documents bearing the file number 751.82 concern political relations between France and Liberia. These three areas for which records are also included in this series were each assigned a letter as follows: g (French Indochina), r (Algeria), and s (Tunis), which is placed after the country number for France (51). Thus the documents bearing the file number 751s.65c, for example, concern political relations between Tunis (51s) and Libya (65c).

When two country numbers are used in a single file number, the lower number is the controlling one and precedes the decimal point; the number after the decimal point must be higher. Most of the documents reproduced in this microfilm publication concern relations between France and those countries assigned a number higher than 51. Documents on relations between France and countries having a number lower than 51 would be among records for the other country; for example, those on relations between Great Britain (41) and France (51) would be filed under 741.51. Documents relating to French relations with other countries in

general, however, are filed under 751.00 and are included in this publication.

When one or more digits follow the second country number, they represent a specific subject. This number, in turn, may be followed by a slant mark (/). In such cases the numbers after the slant mark were assigned to individual documents as they were accumulated on a specific subject. For example, a decimal file number taken from a document reproduced in this microfilm publication is 751.8215/276. The number 15 following the country number for Liberia (82) signifies that the subject is boundary questions, and the number after the slant mark indicates the number of documents on this subject.

The documents under one subject classification are generally in chronological order, coinciding with the document number assigned (which follows the slant mark). There are instances, however, when a document file number was not assigned until a date considerably later than the one on which the document was received.
